Agency Updates</p>	<p>Whitley County Health Department Debra Brown McNaughton, R.S.</p> <p>Baptist Regional Medical Center Teresa Cobb, RN</p> <p>Delta Gas James Potter</p>	<p>Debra reported on some of the projects that the health department has been involved in. The Whitley Co. Medical Reserve Corps recently deployed 9 members to help in Special Needs Shelters in Western Ky. due to the recent ice storm. The HD also sent 7 (MRC) employees to respond to the windstorm in Whitley County by doing damage assessments.</p> <p>Teresa reported that BRMC was having bi-monthly disaster drills and were also focusing on child abduction trainings. She discussed the medical surge unit and invited the group to participate in the Region 11 Healthcare group Tabletop Exercise (TTX) in August.</p> <p>James reported that Delta Gas was meeting with the Ky. Transportation Dept. and Homeland Security for the purpose of awareness training. They were sending out letters to 1st Responders informing them of where their facilities are located, what heavy equipment they have and their overall resources they have available in case of a disaster. They do presentations in even years and do mail outs in odd numbered years. There are 1,300-1,400 miles of natural gas pipelines in Whitley County.</p>

They would need 15-30 per class in order to have the training.</p> <p>Ryan is interested in having a walk-thru at Firestone to help in his planning efforts. He is currently working on disaster plans and wants LEPC help in determining what to do in different types of emergencies.</p> <p>Bob reported the CSX Engines can be used as generators for hundreds of homes and that diesel fuel is kept onsite for emergency heating.</p>
